Liability Release and Code of Conduct

MEMBER **NON-MEMBER**

(Every member and/or participant is required to sign a form every year.)

Thurmont Riding Club is a family oriented club. The officers of the club reserve the right to expel any person from a club sponsored event, without refund of any fees, for cruelty to animals, unsportsmanlike conduct, excessive profane language and/or use of drugs or alcohol. First offense will result in a verbal warning, second offense will result in a written warning and the third offense will result in said person being expelled from Thurmont Riding Club. The offenses will accumulate throughout the show calendar year. Any member may be removed from membership (without refund) by a two-thirds (2/3) vote of the membership present at any monthly membership meeting for conduct deemed prejudicial to the Club provided such member shall have first been served written notice of the accusation against him and to produce his witness and be heard at the meeting at which such a vote is taken. Said person is barred from club activities until a club vote has been made.

All riders under 18 are required to wear an approved helmet while mounted. All dogs must be on a leash. Thurmont Riding Club will not be held responsible for any loss or injury incurred at any club event or on show grounds. Participation is at your own risk. Thurmont Riding Club well water has not been tested, use at your own risk. The by-laws, general rules, show series rules and code of conduct of The Thurmont Riding Club, Inc. will be enforced.
